Dear Members of the General Assembly:

This document information fulfills the statutory directive that the Department of Commerce and Economic Opportunity (DCEO) report to the members of the General Assembly on the status of the Economic Development for a Growing Economy (EDGE) Tax Credit Program.

The purpose of the EDGE Tax Credit Program is to promote job creation and retention in Illinois through the award of tax credits to eligible businesses.

On December 14, 2009, Governor Quinn signed into law legislation proposed by the Governor and passed by the General Assembly that enables the auto industry, which is among Illinois' largest employers, to retain employee income tax withholdings as an alternative to current EDGE corporate tax credit.

Since the Economic Development for a Growing Economy Tax Credit Act was passed by the General Assembly in 1999, through December 31, 2009, DCEO has received 596 EDGE Tax Credit applications of which 436 have been approved.

I trust that the following EDGE Tax Credit Annual Report for calendar year 2009 will be both informative and useful.

ECONOMIC DEVELOPMENT FOR A GROWING ECONOMY (EDGE) TAX CREDIT PROGRAM CALENDAR YEAR 2009 REPORT

One of the most successful economic development tools provided by the General Assembly and Governor Pat Quinn is the Economic Development for a Growing Economy (EDGE) Tax Credit Program.

The EDGE Tax Credit Program is a targeted tax incentive program that provides tax credits for businesses that create new full-time jobs, retain existing full-time jobs and make capital investments in Illinois. The EDGE Tax Credit Program is designed to help areas of Illinois that are in direct competition with other states for jobs and development.

The following report identifies the guidelines and accomplishments of the EDGE Tax Credit Program.

EDGE Eligibility Requirements

The Illinois Economic Development for a Growing Economy (EDGE) Tax Credit Program is intended to help the state compete with other states for the location of job creation or retention projects.

The Illinois EDGE Tax Credit Program is operated by the Illinois Department of Commerce and Economic Opportunity. Based on a review of a written application submitted by an interested firm, the Department is authorized to designate qualified businesses as "eligible". Eligible businesses may claim a nonrefundable tax credit against their state income taxes. (The amount of the tax credit is calculated based on the income taxes paid by new employees and the retained employees.)

The designation is contingent upon the business undertaking a development project that:

- Involves at least a \$5 million investment in capital improvements placed in service in Illinois and employs at least 25 New Full-time Employees within the state as a direct result of the project; or
- Involves at least a \$2.5 million investment in capital improvements placed in service in Illinois and employs at least 50 New Full-Time Employees as a direct result of the project; or
- Involves an investment in a sufficient amount to employ at least 25 New Full-time Employees, provided the project is located within or serves a distressed area or hires low-income workers; or
- Involves an investment at a level specified by the Department in capital improvements to be placed in service; employs New Full-time Employees within the state at a level specified by the Department; and provides substantial economic benefit to the state, as determined by the Department. The Director may approve projects that do not meet the minimum job creation and investment thresholds for an applicant meeting all other requirements in the Act, providing that one or more of the following conditions are met:
 - A) the applicant's business is located in a distressed community with an unemployment rate which is higher than the state's average; or
 - B) the applicant's business is located in an area with limited economic development prospects as evidenced by prior and current development activities; or
 - C) approval would support a business with potential to generate additional growth in the area and create jobs as a result of spin-off businesses; or
 - D) approval would avert the loss of one of the area's major sources of employment.
- Involves a company with 100 or fewer Full-time Employees whose investment will be at least \$1,000,000 in capital improvements which will be placed in service at a designated site in Illinois and employ at least 5 New Full-time Employees at a designated site as a direct result of the project.

Competitors' Tax Credit Programs

Illinois' primary competitors for business locations and expansions are the bordering states of Kentucky, Indiana, Iowa, Missouri and Wisconsin. These states have similarly adopted tax credits as incentives for businesses locating or expanding operations. Those programs most similar to the EDGE Tax Credit Program in neighboring states are:

- Kentucky Rural Economic Development Act (KREDA) – Kentucky
- IA Industrial New Jobs Training Act – Iowa
- Economic Development for a Growing Economy (EDGE) – Indiana

Table I below shows the similarities of the programs and highlights the advantage of the Illinois EDGE Tax Credit Program:

The Table illustrates that the EDGE Tax Credit Program is competitive with those of bordering states. Other competing states in which Illinois was chosen as the final project site include the following: Massachusetts, Pennsylvania, New York, South Carolina, Arizona, Oklahoma, Nebraska, California, Colorado, Florida, Connecticut, Virginia, Minnesota, Georgia, Maryland, Texas, Michigan, Arkansas, Ohio, Kansas, North Carolina, New Jersey and Nevada.

Description of Projects

The following is a description of each project, which was approved in Calendar Year 2009, which began on January 1, 2009 and ended on December 31, 2009.

EDGE PROJECT INFORMATION

Alorica Inc.

Alorica Inc. will build out a 45,000 square foot facility in Machesney Park which will employ various customer assistance, technical and managerial support positions in Illinois. This is a new site for Alorica and its first location for customer service operations in the state.

Alorica Inc. will create 500 full-time jobs within 2 years and will make a Capital Investment of \$6,162,758.

Alpha Baking Company, Inc.

Alpha Baking Company, Inc. facility, located at 4545 W. Lyndale, Chicago, Illinois has been operating as a bakery since the 1940's. A facility that is in excess of 65 years old requires a significant investment each year to keep it operating and to adhere to the ever increasing food safety regulations. In order to meet the various food safety and other regulatory requirements along with general maintenance needs of a facility this old, Alpha Baking Company, Inc. has identified projects that need to be completed in the next two years. In addition, the facility is in a federal non-attainment zone, which has increased pollution control requirements. It is anticipated additional environmental regulations will be imposed on businesses located in federal non-attainment zones, which add costs to operating the Lyndale facility.

Alpha Baking Company, Inc. will retain 247 full-time jobs and will make a Capital Investment of \$2,100,000.

Astellas Holding US, Inc.

Due to changes in the company's global management system and significant expansion in the United States, Astellas Holding US, Inc. has outgrown its current national headquarters facility in Deerfield. Astellas considered several options to accommodate its additional growth. The Company decided to relocate to Glenview.

Astellas US LLC itself and through its wholly-owned subsidiaries and its related entities will create 150 new full-time jobs and will make a Capital Investment of \$140,000,000.

BOMAG Americas, Inc.

BOMAG Americas, Inc. (BOMAG) currently has two manufacturing facilities in the U.S., one in Kewanee, Illinois and the other in Warrensburg, Missouri. One of the locations is to be relocated to the other facility. BOMAG's operations will be retained at the Kewanee, Illinois location.

BOMAG Americas, Inc. will retain 100 full-time jobs and will make a Capital Investment of \$400,000.

CAMtek, Inc.

Currently located in Bloomington, Illinois, CAMtek, Inc. is an Electronics Manufacturing Services (EMS) provider, specializing in technologically advanced printed circuit card assembly and other value added services to a wide range of industries including: aerospace, medical, military, communications, agriculture, and large equipment manufacturers.

CAMtek, Inc. has outgrown its current leased facility and expanding at its current location is not an option. After looking locally, state wide, and in nearby states, CAMtek will expand into the vacant building located at 2402 East Empire, Bloomington, Illinois (previously known as the IRS building). Initially, CAMtek would occupy approximately 98,000 square feet.

CAMtek, Inc. will create 29 full-time jobs, retain 37 full-time jobs and will make a Capital Investment of \$4,889,237.

CCH Incorporated

Presently, CCH Incorporated owns a facility at 2700 Lake Cook Road in Riverwoods, Illinois and a facility at 4025 W. Peterson Avenue in Chicago, Illinois. The project would include facility and system renovations.

The Company will retain 350 full-time jobs and will make a Capital Investment of \$3,400,000 in Riverwoods, Illinois. The Company will also make a Capital Investment of \$6,644,000 in their Chicago, Illinois facility. The total Capital Investment will be \$10,044,000.

Cole Parmer Instrument Company

Cole Parmer Instrument Company's current lease at their facility expires next year. The building is 30 years old with an aging material handling system. Large amount of office space is unused. Storage capacity is limited by ceiling height. The Company reviewed several options to remain competitive.

Cole Parmer Instrument Company will create 20 full-time jobs, retain 255 full-time jobs and will make a Capital Investment of \$12,769,167.

Combined Insurance Company of America

In 2008 Combined Insurance Company of America undertook a company-wide effort to become more efficient and operationally effective. The effort includes initiatives that strive to eliminate, simplify, consolidate, automate or outsource as appropriate many of the processes in the front and back offices in all countries where Combined conducts business and touches all areas of the company. In order to reduce real estate costs, Combined is relocating office space in Chicago.

Combined Insurance Company of America will retain 410 full-time jobs at its new facility at 111 East Wacker Drive, Chicago, Illinois. The Company will make a Capital Investment of \$11,500,818.

Dawn Food Products, Inc

Dawn Food Products, Inc. plans include consolidating its existing manufacturing operation into five regional manufacturing sites and five regional distribution centers. Dawn Food Products determined that its manufacturing expansion will occur at its Manteno location.

Dawn Food Products, Inc. will create 77 full-time jobs and will make a Capital Investment of \$4,000,000.

Deere & Company

Deere & Company is proposing to expand the Worldwide Product Engineering Center (PEC) in Silvis, Illinois along with investing significant capital at the East Moline, Illinois Harvester Works Factory in support of a new Combine Model. There will be a total of 190 full-time Illinois jobs retained at the Silvis Product Engineering Center.

Deere & Company's Capital Investment will be \$68,000,000.

DeVry, Inc.

DeVry's lease at its current home office in Oakbrook Terrace expires in 2010. DeVry is seeking to expand its services and operations while at the same time reduce costs and increase efficiencies. The Company evaluated several real estate options in and around the Chicago area as well as considering moving some of this home office requirement to existing DeVry offices throughout the United States. DeVry will relocate to Downers Grove.

DeVry, Inc. will create 25 full-time jobs, retain 12 full-time jobs and will make a Capital Investment of \$17,857,322.

Dover Corporation

This is a Global Headquarters relocation project. For the last 40 years, Dover Corporation has been headquartered in New York City. Dover's corporate executive management team is located in New York City. The head offices of its four businesses are located in four other states. The lease on Dover's current New York City (headquarters) space will expire in 2011. Facing this impending lease expiration, Dover has determined that it wants to consolidate these five offices, located in five states, into a single location to improve the efficiency and effectiveness of their corporate leadership team.

Accordingly, Dover began exploring options outside of Manhattan, focusing on the Northeast Corridor, and the Chicago and Atlanta metropolitan markets.

The project proposed in Illinois would move all C-level executives and their related personnel to a property in the Downers Grove area. Overall, by consolidating and moving its Global Headquarters in and to Illinois, Dover would create 90 full-time jobs in Illinois and would retain 12 full-time jobs that are presently based at one of its affiliates in Downers Grove, Illinois.

Dover Corporation will make a Capital Investment of \$18,208,238.

E. I. DuPont and Company

E. I. DuPont and Company is expanding its El Paso, Illinois facility. The operations will formulate over 100 different products for corn, soybeans, cereals and specialty crops. It is located on 15 acres with an additional 32 acres utilized for agricultural purposes. The manufactured products serve the North and South American markets.

E.I. DuPont and Company will create 10 full-time jobs and retain 64 full-time jobs. The Company will make a Capital Investment of \$2,000,000.

Enterprise Recovery Systems, Inc.

The project is in anticipation of an award to Enterprise Recovery Systems, Inc. (ERS) for collection services on an outstanding procurement issued by the United States Department of Education.

The Company has outgrown their facility in Westchester, Illinois and has identified a larger facility in Oak Brook, Illinois.

Enterprise Recovery Systems, Inc. will create 50 full-time jobs, retain 155 full-time jobs and will make a Capital Investment of \$6,165,917.

Flavorchem Corporation

Flavorchem Corporation considered expanding its production capabilities in either Illinois or California thus eliminating current production and efficiency constraints. Flavorchem Corporation will be relocating its flavor and powdering unit from 1525 Brook Drive to 1528 Brook Drive, Downers Grove, Illinois. Flavorchem Corporation will be leasing approximately 41,000 square feet of additional space.

Flavorchem Corporation will create 5 full-time jobs, retain 28 full-time jobs and will make a Capital Investment of \$4,781,631.

FMS Investment Corp. (Rockford)

FMS Investment Corp.'s (FMS) project involves the establishment of an entirely new branch in Rockford. The primary motivation for establishing this site is to accommodate the Company's recent award of the U.S. Department of Education contract/Task Order. The implementation and execution of the Task Order will require FMS to convert the existing infrastructure (a former "Value City" location) into a call center environment.

The Company will create 200 full-time jobs and will make a Capital Investment of \$2,923,074.

FMS Investment Corp. (Schaumburg)

FMS Investment Corp.'s (FMS) project involves the expansion of the Company's existing site in Schaumburg. The primary motivation for establishing this site is to accommodate the Company's recent award of the U.S. Department of Education contract/Task Order.

The Company will create 100 full-time jobs and will make a Capital Investment of \$3,036,070.

Fox River Foods Inc.

The expansion project includes construction of 41,589 square feet of refrigerated storage space that will be owned by FRF Leasing and leased to FRF Systems – lease payments made by Fox River Foods Inc. Construction activities include demolition of an existing building on the site and construction of the new storage space, architectural and design fees.

Fox River Foods Inc. will create 50 full-time jobs, retain 25 full-time jobs and will make a Capital Investment of \$3,097,629.

Golden Rule Insurance Company

Golden Rule Insurance Company was incorporated on June 17, 1959 and began operations in Lawrenceville, Illinois. The Company has emerged as one of the leading providers of health insurance to individuals.

The construction project proposed for Lawrenceville is the construction of a 31,000 square foot addition to existing facilities. This structure will replace a 15,000 square foot building, which was lost in a fire in October, 2007.

Golden Rule Insurance Company will create 25 full-time jobs, retain 196 full-time jobs and will make a Capital Investment of \$5,200,000.

Hart & Cooley, Inc.

Hart & Cooley, Inc. intends to consolidate a number of production lines into a single location. It is pursuing a 250,000 square foot manufacturing facility in Carol Stream, Illinois. This would solidify

Northern Illinois as an important production center for the company. The project will nearly double the current production space and job count for the company in Illinois.

Hart & Cooley, Inc. will create 35 full-time jobs and retain 60 full-time jobs. The Company will make a Capital Investment of \$12,292,450.

Heartland Bakery Company, LLC

Keystone Bakery Holdings (KBH) evaluated the investment of growth capital into the newly acquired Heartland assets and keeping the plant in Du Quoin or relocating the operating assets of the business to an existing facility located in New York.

KBH decided to expand its presence into the cookie category by keeping the plant in DuQuoin. Heartland Bakery Company, LLC will create 60 full-time jobs and will make a Capital Investment of \$665,312.

HEAT Armor, LLC

HEAT Armor, LLC is a start-up limited liability company. The project involves setting up a manufacturing and assembly plant to manufacture armored passenger vehicles and related parts, components and systems. The location is 4400 W. 45th Street, Chicago, Illinois.

HEAT Armor, LLC will create 25 full-time jobs and will make a Capital Investment of \$4,357,042.

Heritage Environmental Services, LLC

Heritage Environmental Services, LLC currently has a regional industrial transfer station in Bellefontaine, Missouri. Increased customer demand for its services has caused the company to outgrow its current facility.

To accommodate its growing customer demand, the Company considered relocating its existing facility. An initial site search of the metropolitan area has led the company to identify a property in the Signature Industrial Park in Roxana, Illinois for relocation.

Heritage Environmental Services, LLC will create 70 full-time jobs and will make a Capital Investment of \$1,671,984.

Horizon Therapeutics, Inc.

Over the next two years, Horizon Therapeutics, Inc. will be building out its internal operations in alignment with the submission of the NDA to the FDA. Pending FDA approval, a ramp up of a national sales force to successfully launch its leading candidate will be developed.

Horizon Therapeutics, Inc. will create 50 full-time jobs. The Company's Capital Investment will be \$3,956,047.

Intermountain Electronics, Inc.

Intermountain Electronics, Inc. (IE) will expand into the Midwest with a new state-of-the-art facility.

IE plans on building a new 40,000 square feet facility with an initial Capital Investment of \$2,000,000 in Mt. Vernon that will create 20 new full-time jobs.

James Hardie Building Products, Inc.

James Hardie Building Products, Inc. will consolidate the physical residence/office in the USA and will relocate the executives from the Netherlands to the United States. The Company considered its three main offices in the USA (Southern California; Irving, Texas; and Chicago, Illinois) for the consolidation.

James Hardie Building Products, Inc. will create 22 full-time jobs and will make a Capital Investment of \$3,172,669.

Kaplan Higher Education Corporation

Currently, Kaplan Higher Education Corporation's employees occupy premises in four separate buildings in Chicago under four (4) subleases and one (1) direct lease, all of which are set to expire soon. Due to lease encumbrances and space limitations, Kaplan's potential growth has been stymied and the company cannot efficiently facilitate future growth at its present facilities. By consolidating its Midwest operations, Kaplan hopes to eliminate redundant functions and costs.

Kaplan Higher Education Corporation will retain 400 full-time jobs between two facilities and make a Capital Investment of \$24,120,174.

Lockheed Martin Information Systems & Global Services

Lockheed Martin Information Systems & Global Services, a division of Lockheed Martin Corporation, is currently located in several buildings in O'Fallon, Illinois. The facilities occupied have reached maximum capacity. In order to successfully work existing contracts on USTRANSCOM's mission critical Global Transportation Network, as well as grow and compete for new contracts supporting USTRANSCOM, Air Mobility Command, Surface Deployment Distribution Command and commercial markets, Lockheed Martin must invest in adequate facilities.

The new project consists of occupying a newly constructed 50,000 sq. ft. facility in O'Fallon. Lockheed Martin will create 60 new full-time jobs.

The Company will make a Capital Investment of \$15,400,581.

Magnum Steel Works, Inc.

Magnum Steel Works, Inc. will expand at its current location in Mt. Vernon, Illinois. The Company operates in a 33,000 sq. ft. building. The company will add an additional 30,000 sq. ft. to allow them to increase production to meet the demands of the emerging mining industry in Illinois, Indiana and Kentucky.

Magnum Steel Works, Inc. will create 25 full-time jobs, retain 40 full-time jobs and will make a Capital Investment of \$1,682,220.

Medline Industries, Inc.

Medline Industries, Inc. is acquiring land and constructing up to a 120,000 square foot office building. The new facility would relieve the extreme crowding of employees at the existing building located on the current headquarters campus in Mundelein, Illinois and would enable the Company to accommodate its continued growth.

The Company will create 35 full-time jobs, retain 607 full-time jobs (of which some will be located at the Medline facilities in Vernon Hills, Waukegan and the existing Mundelein facility) and will make a Capital Investment of \$11,000,000.

Menlo Logistics, Inc.

Menlo Logistics, Inc. helps their customers achieve more efficient global supply chains by providing them with better visibility of their worldwide inventory, lower costs for systems integration and management and lower transportation expense.

The activities for which Menlo Logistics, Inc. is considering jobs in Joliet will involve warehousing, repackaging, export compliance, and distribution for a worldwide manufacturer, in full support of interstate and international commerce.

The Company will create 100 full-time jobs and will make a Capital Investment of \$7,877,149.

MicroSun Technologies LLC

MicroSun Technologies LLC's shareholders acquired an established operating business in Nevada in late 2007. Recently, the shareholders have been approached by local economic development officials to relocate the Company's Illinois operations to Nevada, due to cost and labor advantages. The Company is currently located in Lisle, Illinois. The Company's lease will be up in the very near future.

MicroSun Technologies LLC will create 5 full-time jobs and retain 85 full-time jobs and will make a Capital Investment of \$3,200,423.

MillerCoors

With 8 major and 2 regional breweries in the US, MillerCoors was seeking a new headquarters location to house the majority of senior executives, as well as Marketing, Human Resources, Legal, Finance, IT and Communications divisions. MillerCoors selected Chicago.

The Company will create 275 full-time jobs, retain 25 full-time jobs and will make a Capital Investment of \$18,833,702.

NAL Worldwide LLC

NAL Worldwide LLC has 7 locations across the US. Their National operations are currently in Addison, Illinois; Ft. Wayne, Indiana; Atlanta, Georgia; Dallas, Texas; Monroe, New Jersey; Fremont, California and Fontana, California. Due to the increased costs of doing business, the Company is looking at consolidating operations.

The Company will create 50 full-time jobs, retain 52 full-time jobs and make a Capital Investment of \$7,424,002 in Addison.

National City Mortgage

National City Mortgage will invest \$5 million in order to support the centralization of its mortgage operations. The company currently maintains 72 full-time employees at its existing site that is leased in Downers Grove, Illinois. As a result of the centralization, the company plans to create 400 new-full-time jobs.

NCI Group, Inc.

Through the company's IPS® brand, NCI has become an industry-leading manufacturer of insulated metal panels that are ideal for numerous roof and wall applications. In addition, MBCI®, the industry's leading manufacturer of single-skin metal roof and wall panels are now offering a line of insulated metal panels through their nationwide sales locations.

NCI Group, Inc. will be re-opening a building in Mattoon, Illinois which they closed in October, 2008. NCI Group, Inc. will be constructing metal panels which they did not previously do at this facility.

The Company will create 15 full-time jobs and retain 5 full-time jobs. The Company will make a Capital Investment of \$13,000,000.

Parker Hannifin Corporation

Parker Hannifin Corporation will construct a new, world-class research and development facility and training center in Antioch. The proposed project will result in a corporate managed (as opposed to divisionally managed) facility used to centrally house R & D, sales and training operations.

In connection with the proposed construction of the research and development facility and training center in Antioch, Parker Hannifin Corporation would retain current positions at the Company's manufacturing facility in Lincolnshire, Illinois. The proposed Antioch facility would conduct research and development for parts and systems that ultimately will be manufactured in Lincolnshire. In addition, employees at the Lincolnshire plant would regularly work at the proposed Antioch facility to provide input and expertise during the product development and testing process.

Parker Hannifin Corporation will create 25 full-time jobs in Antioch, Illinois and retain 33 full-time jobs in Lincolnshire, Illinois. The Company will make a Capital Investment of \$4,400,000.

Peerless Industries, Inc.

Despite a down economy, there is still an increasing demand for information presented through video and audio. Consumers continue to search for new ways to expand and enhance these audiovisual products while getting the most out of these new technologies through mounting and installation solutions.

Peerless has recently made a strategic decision to bring Asian outsourcing to a North American facility. Peerless Industries, Inc. is also considering doing additional in-house manufacturing in North America.

Management evaluated a number of potential investment options. Peerless Industries, Inc. currently has two sites in Melrose Park which they would close and move to a facility in Aurora.

Peerless Industries, Inc. will create 85 full-time jobs, retain 253 full-time jobs and will make a Capital Investment of \$17,450,000.

Pierce Biotechnology, Inc.

Pierce Biotechnology, Inc. seeks to expand operations on its current site to support growth of the business through internal organic efforts, acquisitions, and inter-company collaborations. Pierce will construct a new building to include laboratories, offices, and a site lunchroom and conference center.

Pierce Biotechnology, Inc. currently has 238 full-time employees at its Rockford facility. The project will include the creation of 16 full-time jobs and a Capital Investment of \$5,000,000.

Quality Color Graphics, Inc.

Quality Color Graphics, Inc. houses its printing operation in Elk Grove Village and its finishing operation (die cutting, folding carton and gluing) in Arlington Heights and Chicago Packaging Company in Chicago. The purpose of the applicant project is to unite the three manufacturing operations into one facility. The Company has identified a property in Elk Grove Village that offers adequate manufacturing space,

electrical capacity and parking. (It should be noted that Chicago Packaging Company is not part of the EDGE application due to the reason that they are a standalone taxpaying entity.)

Quality Color Graphics, Inc. will retain 60 full-time employees and will make a Capital Investment of \$4,331,282.

Rasmussen College, Inc.

Currently, Rasmussen College, Inc. occupies 30,000 square feet of leased space at the Burr Ridge location. The project involves the expansion and relocation of the Company headquarters currently located in Burr Ridge to Oak Brook.

The headquarters project in Oak Brook will create 105 full-time jobs and will make a Capital Investment of \$7,660,567.

Redbox Automated Retail, LLC

As Redbox Automated Retail, LLC continues to grow, the Company is now in a position to lease a total of 136,000 square feet of space in Oakbrook Terrace in order to accommodate its rapid growth over the next ten years.

Redbox Automated Retail, LLC will create 38 full-time jobs, retain 58 full-time jobs and will make a Capital Investment of \$30,470,947.

RGH Enterprises, Inc.

RGH Enterprises, Inc. is expanding into an existing vacant facility located in Elgin. The facility is approximately 57,500 square feet, and would house a medical supply distribution center. The project involves the creation of 30 new full-time and a Capital Investment of \$3,360,912.

Rhodia, Inc. will create 5 full-time jobs (University Park location), retain 190 full-time jobs (42 in Blue Island, 33 in Chicago Heights and 125 in University Park) and will make a Capital Investment of \$12,004,400.

RTC Industries, Inc.

The project is a new assembly/warehouse/distribution center facility of 503,200 square feet in Romeoville. The company currently operates in Chicago in a facility that is older and outdated and no longer meets the future needs of the company.

RTC Industries, Inc. will retain 100 full-time employees and will make a Capital Investment of \$9,321,585.

Stericycle, Inc.

Currently there are two main facilities in Illinois that house Stericycle, Inc.'s headquarters and back office functions. The Illinois sites are located in Lake Forest (Main Headquarters – 129 employees) and in Bannockburn (Back Office – 231 employees).

As Stericycle, Inc. has grown rapidly, physical juggling between the two Illinois locations of various corporate and operational departments has become commonplace. This has been required in order to accommodate flux in individual department space needs and is common in corporate “campus” type settings.

Stericycle, Inc. proposes to replace its Bannockburn facility with a facility in Northbrook. The Northbrook site, in conjunction with its Lake Forest facility, will act as the new corporate campus and allow Stericycle, Inc. to maintain and grow.

Stericycle, Inc. will create 25 full-time jobs (23 in Northbrook and 2 in Lake Forest), retain 360 full-time jobs (231 in Northbrook and 129 in Lake Forest) and will make a Capital Investment of \$5,520,065 in Northbrook.

The Sherwin-Williams Company

The Sherwin-Williams Company’s Effingham facility, is a distribution center for paint and paint-related products that services Sherwin-Williams’ stores and other customers in the Midwest region. The facility is currently outdated and Sherwin-Williams intends to make repairs to the existing facility.

The Company will retain 340 full-time jobs and will make a Capital Investment of \$22,301,149.

United Parcel Service, Inc. (Ohio)

United Parcel Service, Inc. (Ohio) will maintain its operations at the Chicago Area Consolidation Hub (CACH) located in Hodgkins and the Rockford air facility.

United Parcel Service, Inc. (Ohio) and Affiliates will retain 3,000 full-time jobs between its Rockford and Hodgkins facilities. The Company will make a Capital Investment of \$91,000,000.

Vetter Pharma International USA, Inc.

Vetter Development Service provides support for its pharmaceutical and biotech clients in the early stages of development, from clinical phases and regulatory approval to worldwide product launch. Vetter Commercial Manufacturing handles the entire production process, from compounding and aseptic filling to the final packaging of a product.

Vetter Pharma International USA, Inc. will establish a new legal entity of the Vetter Development Service in the USA. Chicago is a central hub for the entire US with a good infrastructure for its business. Access to a qualified workforce in pharma, biotech or biomedical and contacts / access to adequate academic institutions is another positive component of the location of the Illinois Science + Technology Park in Skokie.

Vetter Pharma International USA, Inc. will create 15 full-time jobs and will make a Capital Investment of \$12,611,735.

W.W. Grainger, Inc.

In order to accommodate business growth, product line expansion and the integration of a subsidiary, W.W. Grainger, Inc. proposes to relocate its current distribution center in Niles.

The project would include the retention of 330 full-time employees. W.W. Grainger, Inc. is considering purchasing a new and larger distribution center in Minooka making facility improvements to the building, and placing in service material and handling equipment for a total cost of \$80.6 million.

Xttrium Laboratories, Inc.

Xttrium Laboratories, Inc. is expanding and relocating its headquarters and manufacturing operations to Mount Prospect from Chicago. Xttrium is expanding its manufacturing capabilities to meet demand for their generic liquid products. In general, the Company's growth can be attributed to a decline in the number of U.S. liquid pharmaceutical manufacturers and Xttrium's unique capabilities and expertise.

Xttrium Laboratories, Inc. will create 40 full-time jobs, retain 70 full-time jobs and will make a Capital Investment of \$6,000,000.
